The last survey two-plus years ago revealed that the speeders were primarily from our own community. Keep us safe, please, and slow down.

Architectural Review Board. The Architectural Review Board will meet at 7:30 p.m. on July 14th at 12549 Lt. Nichols Road to review all completed applications received at least *seven days* before the meeting. An agenda for the meeting will be posted on the FOEHA Web site (www.foeha.org) prior to the meeting.

Important Note. Please be sure to submit your applications 30 days in advance. It is important that you follow the instructions closely on the application, such as providing a site plan (plat) of your property showing the locations of new decks, removal of trees, and so forth. Incomplete applications will slow the approval process.

ARB June 16th meeting results: Ten applications were submitted for review, including replacement of siding; a new walkway; extension of driveway; landscaping; tree removal; new deck with screenedin porch; fence replacement; window replacements and additional window; kitchen extension; and deck relocation. Nine applications were approved; one was not approved, pending a permit from VDOT.

Open Space Committee. This was a relatively light news month for the Open Space Committee. We worked on tree removal and stream bed and culvert cleaning. There were two trees removed; one had a root field that disrupted a homeowner's yard and another had fallen and was leaning against a homeowner's fence. There is a stream that goes under the path from the small tot lot to Ox Hill Road. It had become clogged and was overflowing with all the heavy rain. Thanks to Bob Milne who did the initial clean-up and to Soo Ung Kim who helped with the final work and also cleared overgrown bushes along the side of the path. We'd also like to thank the Darrah family who picked-up litter and debris at the West Ox Road entrance.

The sprinkler system installation at the two entrances has been delayed because of the rain, which obviated the need for sprinklers anyway! The installation is underway at this writing. The paving contractor also faced rain delays so no work was done on finishing up the work along the path paving at the Washington Brice Road tot lot.

We've noticed that poison ivy is thriving this year. It must like rain! One area we'd like to ensure you are aware of is along the path from the tot lot to Ox Hill Road. Let's continue on the nostalgia theme to celebrate the 25th anniversary of *The Acorn* by including some snippets from the past. These are from the July 1985 issue:

- The pool membership drive kicked into high gear, with telephone calling and door-to-door solicitations. The membership fee was set at \$1,200, which was refundable upon termination of membership.
- The Open Space Committee spent \$38 to repair vandalism damage at the tot lot between Ox Hill Road and Alexander Cornell Drive.
- Mr. Chip Paciulli—a Civil War buff—of Paciulli, Simmons, and Associates (the surveying company that laid out the lots for the developers of Fair Oaks Estates) was identified as the person who prepared a list of potential street names for the neighborhood that drew on local persons, landmarks, and events from the Civil War period.
- House sales included an Amberly model on Charles Stewart Drive on a corner lot with deck and walk-out basement that sold for \$159,500.

The Acorn July 2009 CHANTILLY HIGH SCHOOL SPORTS NEWS

Chantilly High School had a great spring sports season, and a couple of Fair Oaks Estates students played major roles.

- The Girls Varsity Soccer Team won the 2009 Virginia State Championship for the first time in school history! The Chantilly girls won the championship game 2-1 against Mills Godwin High School from Richmond after having won the District and Regional titles. Senior **Kaitlyn Manley** on Charles Stewart Drive was one of the the captains of the 2009 team, which finished the season with a record of 20 wins, 2 losses, and 1 tie. The Chargers should be strong next year as well, with a number of returning starters.
- The Girls Varsity Lacrosse Team also won the 2009 Virginia State Championship, beating Robinson High School 13-4 in the finals. This was the first time in the four-year history of the official Virginia High School League State Championship that a team besides Oakton High School won. The Chantilly girls ended the season with a record of 21 wins and 2 losses.
- In Boys Varsity Lacrosse, Chantilly was the runner-up in the State Championship this year after having captured the title in 2008. Fair Oaks Estates senior **Derek Kegerreis** on Washington Brice Road was the goalie on the team, which compiled a record of 16 wins and 3 losses this season. In the championship game, Chantilly narrowly lost to Langley High School by a score of 4-3.
- In Chantilly track, **Genevieve Manley** competed in the 100m dash, 200m dash, and 4x100m relay at the District and Regional track meets. Her relay team won the District meet, and a personal-best time of 12.6 seconds in the 100m dash earned her a berth at the Virginia State Track Meet.

YOUTHFUL DRIVER PROGRAM

Is someone you love learning to drive? The Fairfax County Police Department Youthful Driver Program can help. Police instructors will help your "young driver":

- Learn what it means to be an "inexperienced" driver.
- Identify the risks and realities of being teen driver.
- How to ignore peer pressure behind the wheel.

Spend a Saturday learning the rules and risks of the road. Dangers of the road aren't confined to teenagers; everyone on the road will be safer once they learn:

- How to recover from skidding on a wet roadway.
- How to adjust your driving when road surfaces vary, from hard surface to soft shoulders.
- How to judge distance while driving at highway speeds.

The Youthful Driver Program is a one-day, hands-on course, running Saturdays from 7:00 a.m. until 4:00 p.m. at the Fairfax County Criminal Justice Academy, 3725 Stonecroft Blvd. Chantilly.
